Terms and Conditions

1. Candidates must be an Indian Citizen as defined in Article 5 to 8 of the Constitution of India.
2. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with date must be mentioned in their applications.
3. Candidates serving in Govt. Department should submit their application through proper channel.
4. Candidates must have passed Class VIII.
5. If any candidate is found to have suppressed his educational qualifications or given wrong information, at the time of applying for job or later on, his candidature shall stand rejected without any information to him with immediate effect and shall also be liable to Criminal Prosecution as per Law.
6. Candidates must not be less than 18 years or more than 38 years of age on 01/01/2020. The relaxation of age shall be applicable as per government rules
7. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste, Valid Employment Exchange Registration Card, Driving License, Experience Certificate & Character Certificate along with 3 (three) copies of recent passport size photographs, duly signed by the candidate on the reverse side, should reach the office of the undersigned.
