O R D E R

Dated Bongaigaon the 24th March, 2020.

As per Notification No. 18 dtd. 24.03.2020 issued by the Hon'ble Gauhati High Court, Guwahati the functioning of the Courts and Offices of the District Judiciary, Bongaigaon shall remain restricted with effect from 25.03.2020 till 04-04.2020.

Notification No. 11 dated 15.03.2020, Notification No. 14 dtd. 19.03.2020 and also Official Order dated 15-03-2020 and 17-03-2020 issued by the Hon'ble Gauhati High Court for regulating the Court working, the undersigned has been pleased to issue the following directions :-

1. Matters which are already fixed for listing and hearing of all Courts in the District Judiciary, Bongaigaon upto 04-04-2020 shall stand deferred except extreme urgency.

2. Cases involving extreme urgency would be taken up & urgent matter/case may be filed.
