DISCUSSIONS AND RESOLUTIONS

Discussions and resolution as to Agenda No-I.

The Letter No.HC.XLV-46/2014/601/PM&P along with photo copy of memorandum dated 28/11/2020 submitted by Lawyers Clerk's Federation, North Salmara, Abhayapuri to the Hon'ble Gauhati High Court, is placed before the Committee. After discussion the Committee has resolved to constitute a 2 (two) Member Committee consisting of representative from the PWD and the Civil Judge, Bongaigaon for looking into the feasibility of the claim made by the Lawyers Clerk's Federation, North Salmara, Abhayapuri and suitability of the place.

The Committee has also resolved to request the learned Deputy Commissioner, Bongaigaon to depute one Officer from District Administration to assist the Committee.

The District Level Monitoring Committee has resolved to request the newly formed committee to submit report within a month, so that it can be placed before the Committee at the next meeting.

Discussions and resolution as to Agenda No-II.

After discussion the Committee has requested the Assistant Executive Engineer (PWD), Building Division to submit plan and estimate for erection of a structure for hoisting of the National Flag at the front roof top of the Court Building.

Discussions and resolution as to Agenda No-III.

The Committee also discussed the matter of up-gradation of the capacity of Transformer installed in the Court Campus as well as provide better lights in the Court Campus.

The Executive Engineer, (PWD) Electrical Division, is requested to submit the plan and estimate for up-gradation of Transformer installed in the Court Campus for 250 K. V. A. in place of existing 63 K.V. A and also submit plan and estimate for a project of campus lighting in the Court Campus.

Discussions and resolution as to Agenda No-IV.

After discussion the Committee requested the Additional. Deputy Commissioner, Bongaigaon (representing the Deputy Commissioner, Bongaigaon) to initiate process for requisition of suitable accommodation for the Additional District Judge (FTC), North Salmara, Abhayapuri as per direction of Hon'ble High Court Order dated 19/10/2020 in W. P. (C) No. 2865/2016.

Discussions and resolution as to Agenda No-V.

A letter written by Sri Purna Prasad Kakle is placed before the Committee. In his letter he informed that the public toilet used by the litigants in the Court Premises is dirty and there is also shortage of water.

After discussion the Committee requested to the Assistant Executive Engineer (PWD), Building Division for urgently repairing the public toilet at the Court Premises and do the needful for proper cleaning and making water available at the Court premises. He is also requested to ensure regular water supply in the Office premises and submit the estimate for this work done.

It is reported by the Executive Engineer (PWD), Electrical Division that the water pump motor at the Office of the District & Sessions Judge, Bongaigaon has been

replaced 2 (two) times, due to sudden failure of water supply in the Office and considering the urgency of water requirement, new water pump had been fixed only 40 feet below the ground while it should be a minimum of 80 feet under the ground. He also informed that old and used/broken pipes are still under the ground which have to be removed and further boring has to be done under ground up to 80 feet or more i.e. new boring has to be done.

It is resolved that the Executive Engineer (PWD), Electrical Division will ensure regular water supply in the Office Premises and do the needful for the same

Discussions and resolution as to Agenda No-VI

After deliberation the Committee has requested the Assistant Executive Engineer (PWD), Building Division to submit plan and estimate for covering the waiting shed in the Court building of District Judiciary. Presently bird droppings litter the sitting area making it difficult for the litigants/public to use the same. The covering should be in such a manner so that the same can be avoided and yet there should be free air circulation as well as light.

Discussions and resolution as to Agenda No-VII

The Committee discussed the matter of providing/making arrangement for a new water pump boring and water filter system for the Residential Quarters of the Judicial Officers of Bongaigaon. The Committee has requested the Assistant Executive Engineer(PWD), Building Division to verify if already any such project (plan and estimate) has been sent earlier for approval.

At the same time the Chief Judicial Magistrate, Bongaigaon mentioned that temporary arrangement of a water filter by fitting of a separate water tank filled with sand and stone has been set-up at the Official Residence of the Chief Judicial Magistrate, Bongaigaon in order to meet the immediate need for clean water. The same has been functional for the passed 3 (three) months.

The Committee requested the Assistant Executive Engineer(PWD), Building Division to make a similar arrangement at the Official Quarters of the learned Munsiff and SDJM(S), Bongaigaon for water filtration, so that their immediate need for clean water can be met.

Discussions and resolution as to Agenda No-VIII

The report on New Building (RCC) 2-storied for Grade-II Judicial Officers by the Chief Judicial Magistrate, Bongaigaon was placed before the Committee.

The concerns raised in the same were brought to the notice of all members present and the Committee resolved to request the Assistant Executive Engineer (PWD), Building Division to look into the matter and comment on the same.

Accordingly, The Assistant Executive Engineer (PWD), Building Division is requested to submit his comments on the report within 15 days, so that the same can be placed before the Committee on the next meeting.

Miscellaneous

The learned Chief Judicial Magistrate, Bongaigaon also brought to the notice of the District Level Monitoring Committee that all the Residential Quarters of the Judicial Officers in Bongaigaon is in need of a fresh coat of paint. The RCC Building (outer side) also needs white washing as the walls have become stained in many places and is also peeling off. Similarly, other quarters also need fresh coat of paint for regular maintenance.

After due consideration, the Committee resolved that the Assistant Executive Engineer (PWD), Building Division will look into the matter urgently and do the needful in this regard.

The meeting ended with thanks from the chair.
