**As regards Agenda No. 1:**

Deputy Commissioner and Superintendent of Police, Bongaigaon that a Motorcycle and a Scooter which are lying in damaged condition in the Court Malkhana and till date no ownership claimants are found and as such the same may be forfeited as per procedure of law. The additional Deputy Commissioner, Bongaigaon has ensure to look into the matter and will take necessary steps immediately as per procedures of law. The additional Deputy Commissioner has also ensured the Board that he will inform the Board about the progress steps taken in the next meeting.

**As regards Agenda No. 2:**

Regarding the execution of summons, Warrants, P&A etc. by police in all criminal cases issued by the courts, the Chairman-cum- District & Sessions Judge, Bongaigaon has expressed his satisfaction. The S.P. Bongaigaon has ensured to look into the matter of execution of non-bailable warrant and P&A and to follow up the same in the future also.

The Chairman-cum-District & Sessions Judge has brought to the notice of the Superintendent of Police, Bongaigaon that in some old pending cases still no charge sheet has been filed and submitted the list of the cases to the SP, Bongaigoan. The list of **“no charge sheet has been filed”** is annexed here and marked as **annexure-A**. The S.P., Bongaigaon has ensured the Board to look into the matter immediately.

The minutes of the meeting is to be uploaded in the official website of the Bongaigaon District Judiciary. The System Officer is to be directed to do the needful and copies of the same is also to be furnished to all the authorities concerned.
