In the meeting, the following matters were taken up as **per the S.O.P. issued by the N.A.L.S.A** sent by E-Mail dated 17-12-2018 in compliance with the directions of the Hon'ble Supreme Court in W.P. (C) No- 406/2013 in Re-Inhuman Conditions in 1382 Prisons. The Secretary, D.L.S.A placed before the committee the list placed the lists of UTPs under the various categories to be taken up by the committee for consideration under the respective heads. The committee deliberated upon the lists and the matters raised by all concerned and after due discussions took up the resolutions.

1) **U.T.Ps covered under Sec. 436 A of the Cr.P.C.**

The Committee perused the list of UTPs in detail and **found no such case** which required application of Sec. 436 A of the Cr.P.C.

2) **U.T.Ps released on Bail by court but have not been able to furnish sureties:**

The Committee perused the list of UTPs in detail and **found one UTP, being Bapi Sutradhar pertaining to PRC 307/2020 u/s 379/411, IPC** in the court of the Additional Chief Judicial Magistrate in the above category.

Resolutions of Committee:

The committee has resolved that a recommendation may be sent to the concerned learned Trial Court which is the to release the said UTP on P.R Bond if deemed fit as per the resolution dated 26-03-20 of the High Power Committee in pursuance to the Order Dated 23.03.2020 of the Hon'ble Supreme Court passed in RE- "Contagion of Covid-19 Virus in Prisons" (Suo Moto Writ Petition (Civil) No-01 of 2020)

3. **UTPs accused of compoundable offences.**

4. **UTPs eligible under Section 436 of Cr.P.C.**
