Discussed about the construction of Ramp in SDJM (M) Court, North Salmara, Abhayapuri in view of the High Court's letter HC.XLV-13/2014/2380/PM&P dated 04.02.2019 and Judgment dated 26.03.2014 passed by Hon'ble Supreme Court in WP(C) No. 116 of 1998 with regard to the implementation of the provisions of the persons with Disabilities (Equal opportunities Protection of Rights and full participation) Act, 1995.
11. The water contains heavy iron causing damage, to the cloths, stain of floors and regular clogging of filter of aqua guard.

The approached road to the Judicial officer's colony from the main highway road is without any street light and in between the highway and the bunglow of District Judge, Bongaigaon the approach road remains pitch dark.
16. Discussed about the estimates submitted for the construction of vulnerable witness deposition centre & public Toilet in Bongaigaon court campus.
17. Discussed regarding renovation of lock up rooms, which requires same repair works and painting.
18. Discussed about the insufficient coverage in the court rooms with single AC.
19. Discussed about proper functioning of AC door need to be closed for which one glass door transparent is required each of the court room.
