**RESOLUTIONS :**

1. **Resolution No. 1:** The Committee has discussed regarding Pre -arrest bail of the accused person. Sometimes it is seen that the charge sheet is submitted but in the bail bond of the accused taken by O/C., it is not mentioned giving details of order of the pre arrest bail of the accused person. The Superintendent of Police is asked to inform all the O/C's to clearly mentioned about the details of the pre- arrest bail while granting bail of accused who obtain pre arrest bail during the course of investigation.

2. **Resolution No.2:** The committee has discussed regarding the summons issued for Lok Adalat. The Superintendent of Police is asked to inform all the O/C's to direct the person who serve the summons to serve the same on priority basis.

3. **Resolution No.3:** The Committee has also discussed on last meeting regarding submission of MR and Seizure list at the time of submitting charge sheet and the matter is required to be followed by all police station of the District. It is also seen that after repeated discussion some summons are returned without serving to the proper person. Hence, the Supdt. of police is asked to redirect all the O/Cs to serve the summons of the witnesses and accused persons properly to procure their attendance in due time.
