1. Delay in disposal of cases for lack of Information regarding the postings of the Medical Officer and Investigating Officers.
2. Non service of courts process from the police stations under Abhayapuri Sub-Division

DISCUSSION

Agenda No. 1 : Regarding transfer of Medical Officers and Investigating Officers and non service of summons. At time, the name of the Medical Officer and Investigating Officer full name are not given causing confusion delay and service of summons to similarly name of another Medical Officer or Investigating Officer. Non service of summon and non reporting of the same by the Police station falling under the Abhayapuri Sub-Division, more specifically Jogighopa Police station and Abhayapuri Police station.

Agenda No. 2 : At times the summon issued to the police officer is returned unserved with report that the said officer is transferred to another P.S. in the same District for which it has again to be sent at new place of posting, which causes also delay in trial.

Agenda No. 3 : At times the Case Diaries are not produced in time. The bail matters are taken at 10.30 AM. If the CD is received lately, the matter at times can not be taken in time and date has to be re-fixed. It also curtails the rights of deserving accused in some case.

Agenda No. 4 : Non functioning of Consumer Forum since October 2017 for the absence of Members. 60 cases are pending, out of which around 50% of it are 5 years old. The case could not be taken up for absence of the Members.

RESOLUTION

Resolution No. 1 : S.P. Bongaigaon shall instruct the Police Officers to mention the full name and contact nos. of the Medical Officers and the Investigating Officers in the **Charge Sheet** so as to avoid confusion in the proper name and get information of their present place of postings for summoning them.

SP Bongaigaon shall issue instructions to his Sub-ordinate Officers to redirect the summons issued to the Police Officer to the other Police Stations within the District where the officer concerned is presently posted on transfer.

Resolution No. 2 : SP, Bongaigaon to issue necessary instruction to the P.S. under Abhayapuri Sub-Division to serve/execute court processes.

Resolution No. 3 : The Superintendent of Police, Bongaigaon would issue necessary instructions for sending that the case diaries by the Investigating Officers and/or Officer-in-Charge of police stations concerned to the court on the day before the date fixed and in same exigency by 10.00 A.M. of the date fixed.

Resolution No. 4 : The Deputy Commissioner, Bongaigaon will take up the matter with the concerned department for the progress in respect of the appointment of Members to the District Consumer Forum, Bongaigaon.
