: RESOLUTIONS :

Resolution No. 1: The Committee has discussed regarding summons issued to some I/Os where summons are not duly returned after service. The Superintendent of Police is asked to direct all the O/C's of the concerned Police station to serve the summons properly.

Resolution No.2: The committee has discussed in Sessions cases Investigation Officers as I/O namely- Sri Rabindra Deka, Sri Hemanta Neog and Sri M.M. Patowary are not found and their summons are not returned, out of whom the phone number of Hemanta Neog and Sri M.M. Patowary was furnished by DSP present to-day. The Superintendent of Police is asked to collect the phone number and present place of posting of Sri Rabindra Deka and inform to the Court accordingly.

The meeting ended with thanks from the Chair.


