RESOLUTIONS :

2. Resolution No.2: The committee has discussed regarding the bail matters of Juvenile in conflict with law and to follow the procedure prescribed U/S 12 of J.J.B. Act. The Superintendent of Police is asked to inform all the O/C's to follow up the procedure U/S 12 of J.J.B. Act.

3. Resolution No.3: The Committee has also discussed that after several meetings a direction was given to all O/Cs to submit the reports of summons of accused and witnesses carefully and serve to the proper person but it is seen in some cases that the procedure has not been followed and the summons are not timely and properly served. Hence, the Supdt. of police is asked to inform all the O/Cs to look after the matter accordingly.
