**: RESOLUTIONS :**

**Resolution No. 1:** The chief Judicial Magistrate, Bongaigaon furnished list of his own Court and Court of Sub-Divisional Judicial Magistrate (S), Bongaigaon where the cases were pending for non execution of non-bailable warrant of arrest/summons issued against the accused persons to the Addl. Superintendent of Police, Bongaigaon representing the Superintendent of Police, Bongaigaon for looking into the matter and for proper execution of the summons/non-bailable warrant of arrest. In this regard, it was resolved that the Addl. 
