O R D E R

Dated Bongaigaon , the 18th April, **2020.**

Whereas Hon'ble Gauhati High Court has been pleased to extend the notification No- 19 issued by Hon'ble Gauhati High Court on 24.03.2020 till 3rd May, 2020 in view of extension of national lockdown till 3rd May, 2020.

And whereas in view of directions issued by Hon'ble Supreme Court of India in Sou Motu Writ (Civil) No- 5/2020 (in re- Guidelines for court functioning through video conferencing during COVID-19 pandemic) and in view of Notification issued by Hon'ble Gauhati High Court on 15th April, 2020. In this regard, following arrangements are hereby made for the District Courts at Bongaigaon.

1. During the period of National lockdown only the matters of extreme urgency involving liberty of individual (including matters relating to fresh arrests and extension of remand) shall be taken up by the courts, in above locations, on roster basis.
2. For convenience of advocates to take up urgent cases both civil and criminal, the following two E-mail IDs have been created. The lawyers can file urgent nature of cases in the following E-mail IDs.

3. Learned Advocates shall be required to download "VidyoMobile" app for mobile user from Play Store or App Store and download "VidyoDesktop" app for desktop or laptop from <http://ecourtvc.nic.in/download.html?lang=en> for the purpose of availing the facility of video conferencing.
4. Alternatively, Learned Advocates are advised to install zoom video conferencing app in their smartphone from Play Store (for android phone) or App Store (for iOS) as well as desktop/laptop from <https://zoom.us/support/download> as a secondary option. Learned Advocates can also address the court through Whatsapp Video calling.
5. The Learned Advocates shall be required to give intimation to the following officials of the District Court, Bongaigaon at their mobile numbers at least three days before the proposed day of the hearing to arrange video conferencing facility.

The advocates who desires to come to the court for urgent hearing of cases, a separate room in the ground floor (Civil Judge court) of court building equipped with video conferencing facilities has been made and the concerned advocate shall avail the video conferencing facilities from the said conferencing room by contacting the concerned officials to take up urgent nature of cases with the concerned court by maintaining social distancing.
7. The hard copies of petitions/cases shall have to be filed as per prevailing practice and rules: however, they shall be taken up for hearing only after three days from the date of such filings. Soft copies of the petitions along with all the Annexure in PDF form shall be submitted in a pen drive, along with the hard copy of the petitions thus filed. After transferring the data from the pen drive by the concerned officials, the same shall be returned to the concerned learned Advocates.
8. All concerned are requested to enter into the court complex wearing proper facemask and after cleaning their hands properly with soap/sanitizer in the basins provided at the entry point of the court complex. They are also directed to maintain social distancing as per the guidelines issued by the Ministry of Health and Family Welfare.
9. Spitting anywhere in the court complex shall be punishable as per law in view of Order No-40-3/2020-DM-I(A) dated 15th April, 2020 issued by Union Ministry of Home Affairs.
10. Above arrangements shall continue until further orders
