Students, Anganwadi Workers, Doctors/Physicians, Law Students (till they Enrol as Advocates), Members of Non-Political, Service Oriented NGOs and Clubs, Members of Women Neighborhood groups, Maihtri Sanghams and other Self Help Groups.

The candidates should have minimum matriculate qualification and capacity for overall comprehension, who do not look up to the income they derive from their services as PLVs and who have a mind-set to assist the needy in society coupled with the compassion, empathy and concern for the upliftment of the marginalised and weaker sections of society.

It is to be mentioned that the work of PLVs does not carry any salary, remuneration or wages except honorarium fixed by the Assam State Legal Services Authority from time to time.
