Applications were invited for filling up of 2 (two) nos. of vacant post of Grade IV Peon under the Chief Judicial Magistrate Establishment, Bongaigaon vide advertisement dated 20/01/2023 in the 'Asomiya Pratidin' and 'The ASSAM Tribune' Newspapers. A total of 123 nos. of applications were received out of which 91 applicants are found eligible for appearing in the Interview/Viva-voce to be held on 28.02.2023, 01.03.2023 and 02.03.2023. The list of provisionally eligible candidates along with their Roll Nos. for appearing in the Interview/Viva-voce is enclosed herewith and also published in the official website of the Bongaigaon District Judiciary. The eligible candidates are directed to appear for the Interview/Viva-voce as per the instructions and guidelines provided hereunder.

The list of rejected candidates is published in the official website of the Bongaigaon District Judiciary and the Notice Board of Chief Judicial Magistrate Establishment, Bongaigaon.

Candidates bearing Roll. No. from 1 to 30 are directed to appear for the Interview/Viva-voce to be held on 28.02.2023 from 3:30 PM onwards at the Office of Chief Judicial Magistrate, Bongaigaon. The candidates bearing Roll. No. from 31 to 60 are directed to appear for the Interview/Viva-voce to be held on 01.03.2023 from 3:30 PM onwards and the rest of the candidates bearing Roll. No. from 61 to 91 are directed to appear for the Interview/Viva-voce to be held on 02.03.2023 from 3:30 PM onwards at the Office of Chief Judicial Magistrate, Bongaigaon. **(See the Schedule of Interview/Viva-voce at the bottom)**


Instructions for Interview/Viva-voce

1. All candidates are to report at the venue for Interview/Viva-voce 45 minutes before time.
2. All the candidates are directed to bring their testimonial in original including identity proof without fail for verification.
3. No Separate call letter shall be issued.
4. No TA/DA will be admissible to the candidates for attending the Interview/Viva-voce.
5. The decision of the Selection Board in all matters would be final and binding on the candidates.
6. Canvassing in any form for selection including change of date, time, venue etc. shall be treated as disqualification.

7. The candidates appearing in the interview/viva-voce shall have to make a declaration regarding his/her educational qualification, and details of offspring (children) as per the format to be supplied to the candidates at the time of interview/viva-voce.
